2015 RULES & REGULATIONS

- Contract Cancellation:** Flavors Festivals, LLC (hereinafter referred to as "FLAVORS FESTIVALS, LLC") reserves the right to cancel a vendor contract at any time for the good of the festival, by its sole discretion or by the direction of its clients. Any cancellations by management will be refunded if vendor has followed the rules and regulations. Cancellation or suspension because of lack of proper permitting/licensing or failure to meet or maintain Festival guidelines will not be eligible for refunds.
- Exclusivity:** We do not provide guaranteed exclusivity to any vendor.
- Booth Placement:** Vendors will be placed according to product type and date of application receipt. We reserve the right to relocate a vendor when necessary even after a space has been assigned.
- Water:** Running water is **not** provided on site by FLAVORS FESTIVALS, LLC. You must supply your own fresh water.
- Electricity:** No personal or small portable generators are permitted on grounds of the event for use within your space. Any electrical needs on site must be requested at the time of application and will be quoted accordingly and provided at an additional charge and based on availability/accessibility.
- Music:** The festival limits the playing of recorded or live music in your space. All music must be pre-approved by the FLAVORS FESTIVALS, LLC. All talent booking must be done solely by FLAVORS FESTIVALS, LLC. Unless granted permission by FLAVORS FESTIVALS, LLC, no live performances are allowed in your Festival space.
- Tax Payments & Laws:** Vendor shall be responsible for reporting and payment of all taxes in accordance with applicable laws and regulations, including, but not limited to State of Florida's sales tax. Vendor shall provide its Tax ID number in the Contact Information section of this agreement. Vendor shall provide its Tax ID number in the Contact Information section of this agreement. Vendor shall, at all times, comply with Health and Safety requirements, and shall obtain the necessary licensing and/or permits for sampling or sale of items at the Food Booth.
- Set-up and Tear-down:** Each vendor is responsible for setup, take down and clean up of his/her space. Vehicles are NOT allowed on the Festival Grounds (Grassy Areas) at ANY time. Vendors are allowed 2 hours prior to event start for load-in and one hour after event close for break down and to vacate your Festival space. Please bring the necessary assistance/manpower to ensure this.
- No Show Policy:** Artists or vendors who have not checked-in and/or called the Festival Emergency Number (number will be available in confirmation materials) by 3:00 PM Friday, February 27th will be considered a "no-show." "No Show" artists/vendors will not be eligible for refunds, and assigned space(s) will be forfeited to a wait-list.
- Trash Disposal:** Each space must be left clean throughout the event and each night. Trash receptacles and bags will not be provided. Each vendor must provide necessary trash receptacles and bags for garbage inside the booth. Trash (in bags) will be picked up from in front of each vendor space. Anything left behind after published closed hours of the event will be disposed of accordingly and will result in compromising participation in any future event produced by Flavors Festivals LLC.
- Business Conduct:** Vendors and their employees must maintain the highest degree of professionalism in their festival space and on the event grounds at all times. Conduct deemed inappropriate by Festival Management could result in immediate closure of Festival Space and ejection from the Festival altogether. Any costs associated with this process will be the responsibility of the violating vendor. No refunds of fees/deposits will apply.
- Indemnification:** Martin Co. Board of County Commissioners, Indian Riverside Park and The Frances Langford Dockside Pavilion, Flavors Festivals, LLC, its employees, related festival providers of goods and services, or any participating sponsor will NOT be responsible for any injury, loss, or damage that may occur to the vendor, or to the vendor's employees or property from any cause whatsoever prior to, during or subsequent to the period covered by the vending contract; and the vendor signing this contract expressly releases all of the foresaid from, and agrees to indemnify each of them against any and all claims from such loss, damage or injury from participation in the event.
- Vendor Space:** Vendors must use all space that they are granted and cannot re-sell their assigned space or any portion of this space thereof.
- Event Hours:** Vendors must remain open during festival hours. Failure to comply with this rule will result in the loss of your security deposit.
- Third Party Vendors:** Re-selling booth spaces to third-party exhibitors is strictly prohibited.
- Limitations of Liability:** Neither party shall be liable to the other for any delay or failure of performance due to governmental action, court order, civil disturbance, inclement weather, Act of God or other cause beyond reasonable control of the party whose performance is delayed or prevented. Except as otherwise stated in the Agreement, neither party shall be liable to the other party for consequential damages, including lost profit or revenue, for any breach of the Agreement.

2015 Application/Acceptance PROCESS

Applications **MUST** be submitted with full payment to be considered. There are **NO EXCEPTIONS** to this rule. All payments (including security deposits) will be processed regardless of your status of acceptance into festival. Submission of an application does NOT automatically guarantee acceptance into the festival. All applications will be reviewed by the festival committee. You will be notified of your status approximately 14 business days after submitting your application.

If the event is faced with inclement weather, Acts of God and/or any situation that threatens the safety of exhibitors and patrons, Flavors Festivals, LLC has the authorization to cancel the event which will not result in the refunding of your fees.

1. Cancellations made before December 28, 2014 will forfeit 50% of total fees paid.
2. Cancellations made on or after December 28, 2014 (including the day of event) will NOT be entitled to a refund.
3. Vendor will be charged \$40 for a returned check and cancellation of contract may result for charges submitted and returned as insufficient funds.
